**Order under Section 119 of the Income-tax Act, 1961**

On consideration of representations from various stakeholders for further extension of due date being 30<sup>th</sup> September, 2018 for purpose of filing return of income as well as various reports of audit pertaining to Assessment Year 2018-2019 for assesseees covered under clause (a) of *Explanation 2* of section 139(1) of the Income-tax Act, 1961 (Act), the Board, in partial modification of its order dated 24.09.2018 in file of even number, hereby, further extends the due date for filing of return of income and reports of audit pertaining to Assessment Year 2018-2019 from 15<sup>th</sup> October, 2018 to **31<sup>st</sup> October, 2018**. However, as specified in earlier order dated 24.09.2018, assesseees filing their return of income within the extended due date shall be liable for levy of interest as per provisions of section 234A of the Act.
